



Eleventh Village Vendor Agreement 2021

Vendor Season May 1, 2021 – October 31, 2021

1. I agree to be open for business from 11 a.m. – 4 p.m. on both Saturdays and both Sundays of my registered weeks. I understand that I have the option of being open at any other time during my agreement periods, and that any additional hours that I choose to open are my responsibility to promote.
2. I acknowledge that there is no access to Wi-Fi or electricity.
3. The Eleventh Village welcomes start-up retail businesses offering a wide range of products, and we especially welcome the sale of products handmade, grown or produced by the vendor. The following categories are not permitted: multi-level-marketing (MLM) companies; sales-for-commission or commission-by-appointment vendors; or vendors of explicit or “adult only” products. I certify that my business does not fall into one of the prohibited categories.
4. I acknowledge that I am responsible for providing my own lock and for locking my shop daily when I close. Vendor locks must be combination padlocks, and the code must be shared with the Town, for potential use during emergencies. If I choose to leave my product on site after hours, I do so at my own risk.
5. I acknowledge that no heaters or generators are permitted.
6. I am responsible for providing my own table and chairs, and any other display furnishings I may need.
7. I am responsible for disposing of trash and debris at the end of each day.
8. I agree to leave my shop broom-clean at the end of my registered session.
9. I acknowledge that my security deposit will be returned to me at the conclusion of my agreement period, and that return of the deposit is dependent on my shop being clean and in good repair.

10. Riverside Park is a smoke – free, drug – free, and alcohol – free environment. I agree to abide by this town ordinance.
11. I will report any damage, stolen items or suspicious behavior to the Town of Thompson immediately.
12. I agree not to alter the building in any way including paint and nails.
13. I understand that the Town of Thompson will make any necessary weather related closures and announcements. Closure will only be in the case of severe weather. A \$50 refund will be given for any Saturday or Sunday during my agreement period that the Town closes the Eleventh Village due to weather.
14. I give permission for the Town of Thompson to take photos of me, my shop, and my products for use in promotional materials.

Agreement:

By signing below, I agree that I have read and understand the Eleventh Village Vendor Agreement and will abide by it. I understand that failure to abide by the Vendor Agreement may result in the forfeiture of my security deposit and jeopardize my ability to return for future session/seasons. I understand that the Town of Thompson is not responsible for my actions. I therefore agree to hold harmless the Town of Thompson for any liability, damage, loss, or claim that may occur in connection with the use of the Eleventh Village shops by myself or my guests.
